By signing this application the applicant agrees that the applicant and the owners of any such property (either providing access or where the work is actually conducted) shall hold the City or its contractor harmless and fully indemnify the City or its contractor from any damage or claims that occur by either accessing or working on private property, and will sign a form provided by the City that is reviewed by the City Attorney prior to commencement of such work. The applicant agrees to execute any further indemnification agreement as may be required by the City as a condition for the performance of any such work, and to provide to the City indemnification agreements executed by each property owner impacted by the requested work.

Should the City determine that it will proceed with any work under the provisions of its policy related to Drainage on Private Property (Exhibit "A", Attached to this application), the applicant agrees to provide to the City such evidence of ownership of the property impacted by the work requested. The City may require documents executed by the impacted property owners granting the City necessary rights of entry.

The applicant agrees and understands that the City is limited by Mississippi state law as to which projects may be lawfully undertaken, and that unless the City determines that the scope of the project requested is in compliance with state law, no such work will be performed.
