At this time, two properties for the proposed site of the City Center Complex were discussed. Terms of the sale would include responsibility for the removal of all

equipment, structures, pre-stressed concrete materials, and environmental clean up by the seller. Further discussion excluded slabs and footings from the required removal of concrete materials by the seller. In addition, the seller would have the right to void or renegotiate the contract if environmental clean up costs exceeded \$25,000.00.
