SECOND REGULAR MARCH 2009 MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF RIDGELAND, MISSISSIPPI MARCH 17, 2009 6:30 P.M.

The Mayor called the second regular March 2009 meeting of the Mayor and Board of Aldermen to order. Present were Mayor Gene F. McGee, Alderman Gerald Steen, Alderman Ken Heard, Alderman Chuck Gautier, Alderman Kevin Holder, Alderman Larry Roberts, Alderman Scott Jones, City Clerk David Overby, City Attorney Jerry Mills. PUBLIC HEARING/CONSIDER AMENDMENTS TO ANIMAL CONTROL ORDINANCE

The Mayor announced that the public hearing regarding considering certain amendments to the City of Ridgeland Animal Control Ordinance is now open. The City Clerk adjudicated that notice of the public hearing was published in the Madison County Journal on February 26, 2009 and March 5, 2009, copies of the notice is attached hereto as Exhibit "A".

At this time, Jerry Mills, City Attorney, explained that were two (2) ordinances to consider. The first being an ordinance banning specific breeds of dogs from the City of Ridgeland; and the second ordinance is a clarification of the changes to the existing Animal Control Ordinance.

Next, the Mayor invited those who had signed up to speak to come forward as he announces their name, at which time, a number of citizens including Lisa Key, Lesley Mukoro, Elton Holloway, Gloria Grantham, Mary Week, Debra Stringer, Jim Smith, and Michael Smith asked questions and presented their positions in regard to the adoption of the proposed ordinances.

After the Mayor asked if anyone else wished to speak and there was not response, he declared the public hearing closed.

At the conclusion of the public hearing, Alderman Heard requested that the Mayor and Board consider each breed separately prior to the consideration of the ordinance as a whole.

Alderman Gautier moved to include the Staffordshire Bull Terrier in the ordinance banning specific breeds of dogs.
