Woody Sample, the City's Acquisition Administrator, addressed the Mayor and Board regarding a request by Mr. Steve Terney, property owner, proposing revised compensation for the acquisition of a right of way, relocation of a light pole, and a temporary construction easement in Parcel 1 for the Lake Harbour Drive project. Mr. Terney's letter disclosed his compensable value of the land and included compensation, based on price quote, for the relocation of the parking lot light utilized by his long-term tenant. The owner's proposal of \$29,881.00 for revised compensation is \$6,731.00 above the appraisal-based compensation initially offered by the City. Copies of related documents are attached hereto as Exhibit "K".

After discussion, Alderman Steen moved to approve \$29,881.00 in just compensation to the property owner for further implementation of the Lake Harbour Drive project.
