# REVISED COMPENSATION FOR PARCELS 43, 45, 46, 47, AND 50/WHITE OAK CREEK SEWER PROJECT

Next, the Mayor and Board reviewed a memorandum from the City's Acquisition Administrator, Woody Sample, concerning ongoing negotiations with property owners to acquire easements on five separately owned parcels of land for implementation of the White Oak Creek sewer project. Owners of parcels 43, 45, 46, 47, and 50 twice responded to the City's offers of just compensation with counter offers, each of which included a stipulation for the City to provide one (1) sewer connection per parcel at no charge as a condition of the easement agreements.

Alderman Holder moved that the City provide one (1) sewer connection per parcel at no charge and pay the consideration requested by the property owners rather than incur the expense of an eminent domain suit. A copy of Mr. Sample's memorandum detailing revised compensation for each parcel is attached hereto as Exhibit "G".

# REVISED COMPENSATION FOR PARCELS 53, 52, AND 59/WHITE OAK CREEK SEWER PROJECT

Next for consideration came the matter of counter offers from property owners for easements on three additional parcels of land necessary for implementation of the White Oak Creek sewer project. Owners of parcels 53, 52, and 59 presented counter offers requesting increases of just compensation based on estimates for various fencing and landscape replacement.

After the Mayor and Board reviewed memorandums from the City's Acquisition Administrator along with price quotes and estimates obtained by property owners, the following Motions were made regarding revised compensation for said parcels.
