RESOLUTION DIRECTING THE SALE AND AWARD OF GENERAL OBLIGATION BONDS, SERIES 2011 IN THE PRINCIPAL AMOUNT OF FIVE MILLION EIGHT HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$5,825,000); AND A RESOLUTION APPROVING AND AUTHORIZING THE FORM OF, EXECUTION AND DISTRIBUTION OF AN OFFICIAL STATEMENT PERTAINING TO THE FIVE MILLION EIGHT HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$5,825,000) GENERAL OBLIGATION BONDS, SERIES 2011, OF CITY OF RIDGELAND, MISSISSIPPI

After adjudication by the City Clerk that the sale of said bonds had been advertised as required by state law, four (4) sealed proposals were opened and read aloud for subsequent presentation to the Mayor and Board of Aldermen.

Representatives from Butler, Snow, O'Mara, Stevens, & Cannada, PLLC, acting as Bond Counsel, and Government Consultants, Inc., Financial Advisor to the City, reviewed the proposals and provided opinion on the best and most advantageous bid for consideration by the Mayor and Board of Aldermen.

Alderman Jones moved to accept the recommendation of Demery Grubbs, Government Consultants, Inc., to adopt a resolution awarding the sale of the general obligation bonds to Morgan Keegan & Company, being the lowest and best bidder, at the rate of 3.355759%.
