# CANTERBURY SUBDIVISION REQUEST/RESOLUTION ESTABLISHING ADDITIONAL REGULATIONS AND POLICIES FOR PUBLIC STREETS

The Mayor and Board of Aldermen discussed said request with regard to the City's October 3, 2006 policy regarding the use of gates, cameras, speed bumps and other similar devices on public streets and considered a resolution to establish additional regulations to the existing policy.
