MINUTES OF THE FIRST REGULAR SEPTEMBER 2010 MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF RIDGELAND, MISSISSIPPI SEPTEMBER 7, 2010 6:00 P.M.

The Mayor called the first regular September 2010 meeting of the Mayor and Board of Aldermen to order. Present were Mayor Gene F. PUBLIC HEARING/PETITION TO REZONE 517 S. WHEATLEY STREET

City Attorney James Gabriel explained to those present that the Petitioner requests rezoning and reclassifying 517 S. Wheatley Street to change the Use District Classification from R-1 Residential to R-2 Residential following a change in the front set back of the property. Mr. Gabriel further explained that rezoning and reclassifying to R-2 Residential will allow said property to be fully conforming with regard to zoning.
